Hazardous Materials Registration By Type

This report presents a registration breakdown of hazardous materials (HM) carriers and shippers for the last 5 calendar years. The values in the table reflect the counts as of the end of the year for the period selected. Selecting "Calendar" will provide counts based on the December snapshot for the selected year or period.

Note: Entities are considered HM if they meet one of the following criteria: 1) entity is registered as interstate and transports (carrying or shipping) hazardous materials based on their MCS150 form, OR 2) entity is registered as intrastate hazardous material, OR 3) entity is identified as a hazardous material carrier in the SMS system **and** has a recent hazardous material activity.

Note: Companies can register to transport HM materials in Bulk, Non-Bulk, or both, therefore the counts for 'with Bulk Storage' and 'with Non-Bulk Storage' may not equal the sum for a given category.

Filter Options

Filter	Description
Domicile	Carrier domicile is determined at the time of the event. 1) All domiciles: Carriers domiciled in the United States, Mexico, and Canada. 2) United States: Carriers domiciled in the United States. 3) Mexico: Carriers domiciled in Mexico. 4) Canada: Carriers domiciled in Canada.
HM Safety Permit	By default, the filter will be set to 'All'. You can select one of the 4 following options in this filter: 1) All 2) Permanent 3) Temporary 4) Application 5) No Permit
Report Focus	 National is a summary of all States' data and the U.S. territories. Service Center is the region in which the carrier is located. All States includes all States and the U.S. territories. State includes one State's data. Territory includes one Territory's data.
Time Period	Fiscal or Calendar year(s) when events occurred.

Column/Row Descriptions

Column Name	Description
Number of Hazardous Material Carriers	The count of HM Carriers includes those companies who identify their operation as HM Intrastate or as Interstate carriers who register to cargo at least one of any HM materials on their MCS150 form.
With Bulk Storage	Bulk storage or transportation is a quantity larger than 119 gallons.
With Non-Bulk Storage	Non-Bulk storage or transportation is a quantity less than 119 gallons.
Number of Hazardous Material Shippers	The count of HM shippers includes those companies who identify their operation as HM Intrastate or as Interstate shippers only who register to ship any hazardous materials on their MCS150 form.
With Bulk Storage	Bulk storage or transportation is a quantity larger than 119 gallons.
With Non-Bulk Storage	Non-Bulk storage or transportation is a quantity less than 119 gallons.
Number of Hazardous Material Carrier/Shipper	The count of HM carriers and shippers includes those companies who identify their operation as HM Intrastate or as Interstate carriers and shippers who register to cargo and/or ship any hazardous materials on their MCS150 form.
With Bulk Storage	Bulk storage or transportation is a quantity larger than 119 gallons.
With Non-Bulk Storage	Non-Bulk storage or transportation is a quantity less than 119 gallons.
