



Records to Research Report

The Records to Research Report is a supplemental report to the State Safety Data Quality (SSDQ) Measures that helps States identify records not meeting the timeliness, accuracy, or completeness requirements. The report shows details of all records evaluated that negatively affect both the SSDQ Measure and the recent three-month Leading Indicator.

Each SSDQ Measure has its own Records to Research Report available. These reports show States how to correct records, resulting in improved SSDQ Measures. They also identify trends in areas such as: when records are uploaded, from what agencies, and the officers or inspectors who submitted the record. Identifying trends helps States determine what areas to work towards improving.

Timeliness Measures

The Timeliness SSDQ Measures are determined by the percentage of records uploaded to Motor Carrier Management Information System (MCMIS) within the expected timeframe. The Records to Research Report shows details of all records in the Measure and Leading Indicator not meeting the timeliness requirements. For both the crash and inspection reports, use the fields to the left of the black line to find trends in the records negatively affecting the Measure rating.

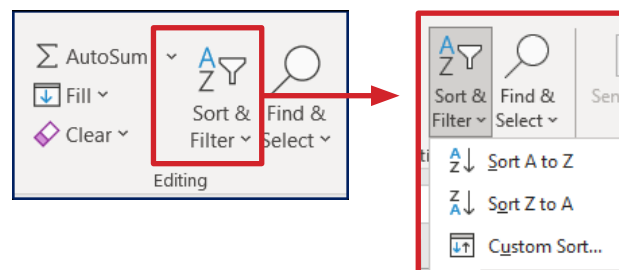

Using the Report

While the timeliness of these records cannot change, States can use this report to identify trends, such as: when the record was uploaded from SAFETYNET to MCMIS, which agency collected the data, and the specific officer or inspector who collected the data.

To find trends in the report, apply a filter to any of the columns. Click the "Sort & Filter" button and then choose "Filter".

You can then choose any column to filter the data in the report.





Completeness Measures

The Completeness SSDQ Measures are determined by the percentage of records that have complete driver and vehicle information. The Records to Research Report shows details of all records negatively affecting the Measure and Leading Indicator which have either missing driver or vehicle information. For both the crash and inspection reports, the fields left of the black line affect the Measure rating. The fields to the right of the black line, are marked “Suspect.” These fields help identify incomplete data in the record. These “Suspect” fields are especially helpful when a field has data entered but the information is incomplete.

Using the Report

The Completeness Measures Records to Research Reports identify records with missing (or incorrect) information related to the driver and/or the vehicle. Applying filters helps identify missing information from the record (e.g., an empty field). States can utilize available resources in the Learning Center ([Legitimately Missing Information](#) Job Aid and [Finding Missing Information](#) Job Aid) and FMCSA’s available tools and systems to locate missing information. Correct the record in SAFETYNET/SafeSpect and upload the revised record to MCMIS. After the next Snapshot, the completed record will be removed from the Records to Research Report and will help improve your State’s rating.



Accuracy Measures

The Accuracy SSDQ Measures are determined by the percentage of records that have carrier information that matches the carrier information in MCMIS. The Records to Research Report details all records negatively affecting the Measure and Leading Indicator with problematic information in one or more required fields. The Accuracy Records to Research Reports display some different column headings between crash and inspection reports. For example, the crash report identifies the Agency and Officer Badge whereas the inspection report identifies the Safety Inspector Key.

- 3 Carrier Name

Using the Report

The Accuracy Measures Records to Research Reports identify records that are missing or contain incorrect information related to the carrier's registration information in MCMIS. Using the same filtering controls described above, use the available information in the record to find the carrier in MCMIS and compare it to the information in the Records to Research Report. Filter by DOT Number, Carrier Name, Carrier Street, etc., to identify groups of records that may be related to the same carrier but have incorrect information. Correct or enter the missing information through SAFETYNET. Once the corrected record is uploaded to MCMIS, it will be removed from the Records to Research Report at the next Snapshot and help increase your State's rating.
